

## Highlights of the July 21, 2005, Regular Meeting of the Minford Local Board of Education

It was an evening of honor, recognition and excitement at the Minford Board of Education meeting.

Alice Butcher who has served Minford Schools as a Bus Driver and Cook was recognized for her many years of service with a plaque presented by Superintendent Dennis Meade. Alice is retiring and the Board and Administration would like to wish her the best in the years to come and thank her for her dedication.

Ralph Hutchinson, former long-time Board Member and Korean War Veteran was presented with his High School Diploma, something that just took a lower spot on his priority list when he left for Korea and served his country well. His family was at the meeting and watched with pride as he was presented the Minford Diploma, mounted with an American Flag background, by Superintendent Meade. Members of the Minford Board, President Troy Huff, Vice-President Anita McGinnis, Joe Stockham, John Jenkins and Mark Caudill thanked Ralph for his call to duty and his return to do so many good services for the Minford School District and the Minford Community.

Lori Rolfe, Academically Advanced teacher and her students, Emma Shoemaker, Amber Gleim and Autumn Ward demonstrated the results of their attendance on an AEP sponsored workshop, called AEGIS (AEP Engineering Girls In Science), They were one of only four groups chosen. Their project was to build an electric bike that would generate electricity to run lights and other appliances.
